Mr. Secretary General,

By letter of August 28, 1967, I had the honour to acknowledge receipt of your communication No. 343a/67 dated August 21, 1967, concerning the respective relations of our two Organisations.

The ICCS Bureau, having examined this communication with particular interest, has charged me to express to you its full agreement on the principle of strengthening the existing ties between the Hague Conference on Private International Law and the International Commission on Civil Status, notably to avoid, as far as possible, that they concurrently deal with the same legal questions in the future.

For this purpose, as you suggest, closer cooperation should be considered between both Secretaries General so that they are required to inform each other of matters included on the agenda and currently under review. However, in the event that one of the Organisations considers that the matter dealt with by the other is also of interest, it shall be responsible for proposing the convening of a joint commission, whose composition, functioning, and powers shall then be determined by mutual agreement.

I would be pleased to know whether, as I hope, the considerations set forth above may serve as the basis for our future cooperation.
